- 3. Central Issue has been published and distributed. Thank you to Abigail LaVictor for her work on this project.
- 4. Our district received delivery of two brand-new buses last week. We also received a used (very good condition) bus last month. These are the first buses the district has purchased in several years.
- 5. Bond Project: Ideas focused on capstone Fine Arts Center, final updates to the Athletic Facility, and updating Stanton Learning Center to Early Childhood Center. Committee has been meeting with Granger and GMB on a bi-weekly basis. District representatives have made several site visits to other West Michigan schools to look at facilities and generate ideas. Next step: Public Input phase. A survey will be available January 17 25 and then they will set up community forums. The goal is to have a 0% increase in millage amounts. Jeff Tulley, Granger representative, said the plan will be finalized by the end of February to be ready for the March meeting with the Michigan Department of Treasury.
