- 1. Congratulations were offered to Brennan Bowen and Jim Lingeman upon their re-election to the Board of Education. We will welcome Jamie Hansen-Hopkins as a new trustee in January.
- 2. Matt Reed shared some highlights from the Fall Marching Band Season. They participated in two separate competitions this year and swept all categories for a First Place finish in each show for Class C schools.


Motion by Lund, supported by Train, to accept and approve the Finance Report for the period ended October 31, 2024. Those in favor 6, opposed 0. Motion carried.
