

The Regular meeting of the Central Montcalm Public School Board of Education was called to order by President Bill Simpson in the High School Student Learning Center on Monday, February 17, 2025 at 7:00 p.m.

Superintendent's Report:


- 1. Hornet Highlights: Students from each building shared events happening in classrooms.

 - c. CMMHS 2024 Yearbook students Madeline Zableckis, Hunter Briskey, Zandria Flint, Evelyn Villet, Sydnee Moreland, Sage Slater. The 2024 Yearbook "What We Have to Say" was submitted to the Michigan Interscholastic Press Association Statewide Competition. Their book was judged in the areas of Unifying Concept, Coverage, Writing, Design/Typography/Graphics, Photography and Reader Services. Mrs. Stephens was proud to announce they were awarded GOLD with Distinction. Additionally, the yearbook has earned a commendation for excellence in Reader Services.
- 2. MTSS Annual Report Assistant Superintendent Mandy McLaughlin: Mrs. McLaughlin reviewed the goals of the MTSS instructional model. Tier I supports all students in behavior and academic instruction such as schoolwide PBIS and core curriculum; Tier II additional supports for students needing extra help such as reteaching, interventions, or small group work; Tier III supports for 5-15% of students needing 1-1 support time such as high intensity remediation and special education. The model is being used to evaluate both academic and behavior systems at the building and classroom level. The District Continuous Improvement Team (DCIT) analyzes data on a monthly basis. The team is aiming to have more staff directly involved in MTSS work through PLC time. Each building has a multidisciplinary team supporting staff in direct instruction and intervention planning.
- 3. Congressional Appropriations: Mrs. McLaughlin also reported Central Montcalm is in the running for a \$150,000 Department of Rural & Community Development Grant. If awarded, this money would be used in expanding our offerings at the ELC to possibly include before- and after-school care, private daycare rooms, and a HeadStart 0-3 program.
- 4. Safer Communities Grant: Mrs. McLaughlin announced Central Montcalm received the Stronger Connections Grant for \$16,000. This will be used to fund a part-time PBIS (Positive Behavior Incentive System) Coach to assist staff in implementing building initiatives by training newer teachers on programs in progress and supporting those in need of classroom management procedures.
