

The Regular meeting of the Central Montcalm Public School Board of Education was called to order by President Bill Simpson in the CMMHS Student Learning Center on Monday, March 18, 2024 at 7:00 p.m.

Superintendent's Report:

- Winter Sports Recognition: Athletic Director Kris Kolbe helped honor several teams and individuals who achieved All-Conference and/or State Competition status this year. Teams introduced included Varsity Boys Basketball, coached by Shea Ingles; Varsity Girls Basketball, coached by Rob Putnam; Varsity Wrestling, coached by Nate Jones; and Bowling, coached by Larry Matson.
- Recognition of Spring Musical Cast from "Shrek": Director Candace Huntley introduced several members of the cast. 35 students were involved with the program this season, ranging from 3rd – 12th grade.
- 3. Hornet Shout-Outs
 - a. CMUE: March is Reading Month in full swing. They are holding a Reading Counts competition between the classrooms where students can read books and earn points.
 - b. CME: Two classrooms have taken on Pen Pals. One class is writing to MCC athletes, one class is trading letters with a classroom in Louisiana. This is an authentic writing project with children practicing these skills for a purpose.
