

The Regular meeting of the Central Montcalm Public School Board of Education was called to order by President Bill Simpson in the CMMHS Student Learning Center on Monday, April 15, 2024 at 7:00 p.m.

Superintendent's Report:


1. White Pine Library – Annual Update: No one was present from the Library Board to share information.

2. Hornet Highlights:

- a. CME: March is Reading Month included guest readers and themed dress up days. A culminating activity was a whole school Read-In and Ice Cream Social. Students who participated could earn a bowl of ice cream, and depending on the number of books read during the month, students could also earn multiple toppings (everybody loves sprinkles!).
- b. CMUE: Students can earn a "Hornet High Five" coupon for following behavior expectations. This year CMUE added a HH5 store for students to spend those coupons, including trinkets and fidgets. They can purchase entry into a monthly themed "mystery room" or pay for an extra recess. Students have already met the end-of-year goal of 85,000 HH5s, and the staff has challenged them to reach the 100,000 mark.

c. CMMHS:

- i. A new elective class offered this year allowed students to train to be certified officials for youth sports. Students have received instruction on umpire/referee requirements and are allowed to take the examination to receive official certification for different sporting events. Students are hoping to earn their stripes in Baseball, Football, Wrestling, and Basketball.
- ii. A Living Organ Donor assembly was held on April 5. Our students received compliments from the presenters on their behavior during the presentation.
- iii. The Swarm Store has been updated and expanded. Driven by student ideas, there is new signage and decorations for the store front.
- iv. Board Members are invited to attend Graduation on May 16. Please let Charity know if you plan to attend so a space can be reserved for everyone.
- d. ELC: Over the last year, the district has received several grants to allow us to upgrade bathrooms, office space, furniture and paint for our preschool wing. We now have 3 classrooms approved for licensing (with a 4th room to be ready for Fall 2024) and have prepared a sensory area/gross-motor room for students to use.

President Simpson addressed the consent agenda.



Motion by Lund, supported by Bowen, to approve the overnight 6th grade student trip to Mystic Lake Camp for May 8-10, 2024. Those in favor 4, opposed 0. Motion carried.
