

A moment of silence was observed in honor of Steve Lacy, who passed away earlier this month. Steve was a long-time volunteer for our Cross-Country teams and assistant coach for Varsity Track.

Superintendent's Report:

- 1. Recognition of Teachers on Alternative Paths to Certification: Central Montcalm has several teachers who are working on earning teacher certification or additional endorsements through alternative pathways. They are completing coursework in addition to teaching full-time. Administration would like to recognize their commitment and hard work.
 - a. Shannon Behrend, GSRP Lead Teacher: Early Childhood Education with Michigan Education Workforce Initiative through Olivet University.
 - b. Amber Beechler, 1st Grade Teacher: BS in Early Childhood Education through Grand Canyon University.
 - c. Scott Cripe, HS Teacher and Football Coach: Educational Specialist Curriculum and Instruction, Physical Education Endorsement with Teachers of Tomorrow and American College of Education. Scott was able to benefit from the Grow Your Own grant received from the State of Michigan to earn his PE endorsement.
 - d. Ashley Hillson, K-2 Music Teacher: PK-3 General Education and K-12 Music with Michigan Teachers of Tomorrow.
 - e. Joshua Hosko, 3rd Grade Teacher: 3-5 Upper Elementary General Education with Professional Innovators in Teaching.
 - f. Ashleigh Braman, former Paraprofessional and current permanent Substitute Teacher: Elementary Education with a Special Education endorsement with Teachers of Tomorrow. Ashleigh is also using funding from the Grow Your Own grant.
 - g. Amber Jones, GSRP Lead Teacher: Adding a Special Education degree with Teachers of Tomorrow, utilizing the Grow Your Own grant.
 - h. Nate Winters-Horton, 5th Grade Teacher, JV Baseball Coach, and Junior Class Advisor: Elementary Education with Talent Together through Ferris State University.
 - i. Stephanie Finney, GSRP Lead Teacher: Early Childhood Education with Michigan Education Workforce Initiative through Baker College.
- 2. Back to School Bash August 12, 2025, 5:30-7:30 pm, Middle School Gymnasium: Sue Kearney is organizing the event, which has a different purpose than an Open House. The Bash will highlight community resources and school-based services and is geared toward all students aged preschool 12th grade. Activities will include a hot dog cookout, visits with the local Queens and their courts, free haircuts from local stylists, vision screening through the Central Montcalm Lions Club and other community support organizations. They are encouraging the vendors to provide goodies for the students to collect as they move through the stations. The Bash was provided donations to cover costs, including a \$2000 grant from the Central Montcalm Community



Foundation and a \$500 grant from Central Montcalm Lions Club. They will be advertising this event in the Central Issue and on Facebook.

- 3. Board Workshop: August 26, 2025, 5:30 pm at Central Office
- 4. All Staff Back to School Breakfast: August 19, 2025, 8:30 am in the Middle School Cafeteria
- 5. Hornet Highlights:
 - a. Jeff Wernette, CMMHS Principal, introduced the new CMMHS Assistant Principal, Ed Beickman.
 - b. Athletic Accolades from the Daily News: Braelyn Bunting DN Softball Player of the Year; Ashley Choponis and Kyah Hoffman DN Co-Runners of the Year; Emmett Lingeman DN Baseball Player of the Year and All-State Baseball honors. These achievements will be recognized in the next Central Issue.
 - c. MI-STEM Scholarships: Jenny Train recently received a scholarship for science training through MI-STEM (Michigan Science, Technology, Engineering, and Math). She spent a week learning through the eyes of a student using a student-driven, teacher-led platform. These Next Gen standards focus instruction on Inquiry Learning and Questioning, and are a big change from traditional teaching methods she learned in her teacher preparation classes. Zachary Parkin received a scholarship for math training and will share his experiences at a later Board Meeting.
- 6. Child Care: Central Montcalm will offer Before and After School child care for Preschool 5th Grade students at the Central Montcalm Learning Center location in Stanton. This is possible through a partnership with YMCA. CM employees will receive a 25% discount on rates. Financial aid options will be available to families. Rates and registration should be available later this week.




President Simpson addressed the consent agenda.

New Business:

Discussion – Hiring Policy: Train suggested implementing a written policy for superintendent and administrator hiring. He would like a committee to review the current policies and procedures, and make a recommendation for future hiring situations. Simpson would like a committee to review the process recently completed for the Superintendent search to find positives and future improvements. Bowen asked if the same committee could complete both tasks. It was mutually agreed one committee could



handle everything. Simpson asked for volunteers for the (ad-hoc) Administrative Hiring Committee: Train, Lingeman, Hansen-Hopkins.

Discussion – Landscaping: Train suggested we reduce the footage of lawn area we are maintaining in the district for both ecological and financial reasons. He would like to investigate grants to cover consulting with a landscape expert and additional grants for implementing any landscape changes the Board would approve. Train cited a program called "Crime Prevention through Environmental Design Principles" that may be beneficial to all school campuses. The USDA and/or local Conservation District may be resources for funding and information. We no longer have a Facilities committee at the Board level. Questions were asked concerning any existing Facilities or Landscaping Master Plan for the district. Harvey Shick, Director of Operations, will be asked to investigate funding and any existing Master Plans.

Discussion – Term Limits for Board Members: Train suggested implementing a Term Limit policy for Board Members. This may also include a review of Board Member responsibilities and expectations. This topic will be addressed at an upcoming Board Workshop.

Motion by Wakefield, supported by Lingeman, to approve the parent and student handbooks for the 2025-2026 school year.
